# **COVID-19 HOUSING ROADMAP**

In response to the COVID-19 public health emergency, President Trump declared a National emergency on March 13, 2020, under Sec. 501(b) of the Stafford Act. Pursuant to this declaration, the Federal Emergency Management Agency (FEMA), the Department of Health and Human Services (HHS), and other Federal departments and agencies began assisting state, local, tribal, territorial (SLTT) governments, and other eligible entities, with response and recovery actions associated with COVID-19.

Concurrently, Congress has passed four supplemental appropriations totaling over \$3 trillion to address emergency, health, economic, social, and other impacts from the pandemic.

This Housing Roadmap describes how these supplemental appropriations and certain annually-funded, steady state programs can be used to address housing challeges and assist in community recovery. Users can approach their housing-related needs by considering the challenge they wish to address or by reviewing programs' profiles.

#### **Navigating the Roadmap**

The Roadmap revolves around four challenges and consists of two parts: Challenge Overviews and Funding Index. The challenges are:

- Rent or Mortgage Payment Shortfalls that may increase the risk to eviction or foreclosure;
- Cost of addressing shelter needs of Homeless populations and provision of Non-Congregate shelter;
- Addressing housing needs of vulnerable populations that have health conditions, disabilities or access and functional needs; and
- Demand for public health-related shelter due to the need for social distancing or other protective measures associated with COVID-19 pandemic.

Challenge Overviews demonstrate affected populations, potential soultions, and programs that support those solutions. When combined, these resources provide an understanding of opportunities and overlapping resources.

The Funding Index provides an overview of the program structure and funding status while connecting each program to the idenfitied housing challenge. Both a Program Link and COVID-19 Guidance Link are provided for further programmatic research.

 $<sup>^{1}</sup>$  It should be noted that the CARES Act provided millions of households with extensive Federal financial assistance in the form of unemployment compensation and stimulus payments that could be used to address housing- related needs. This document does not to elaborate on those resources, but users should recognize that future supplemental appropriations may provide additional assistance to further address household's housing and shelter needs.



#### **Example: Addressing Rent or Mortage Payment Shortfalls**




Figure 1: The red box highlights solutions and resources associated with their specific recovery challenge.

Step 1: Users may begin with the Rent/Mortgage Shortfall Challenge Overview if they wish to consider specific solutions that can be funded by particular programs (Figure 1). Alternatively, users can begin by reviewing the Funding Index to identify the universe of programs that may address the challenge (Figure 2).

Step 2: Once apporpriate programs and solutions have been identified, users should use the embedded "Program Link" and "COVID-19 Guidance" in the Funding Index to access the appropriate agency website and obtain detailed information about issues such as:


- Entities that did or may receive program funding;
- Funding allocation processes and actual awards;
- Eligible uses of funds, including administrative costs and matching requirements;
- Statutory and/or regulatory relief granted by the CARES Act or by agencies that will make it easier to use the funding for COVID-19 response;
- · Operating and administrative instructions for funding recipients; and
- Applicable deadlines.




### CHALLENGE OVERVIEW: RENT OR MORTGAGE PAYMENT SHORTFALLS




