#### **Program Description**

#### Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

<u>OJJDP's</u> guiding philosophy is to enhance the welfare of America's youth and broaden their opportunities for a better future. To bring these goals to fruition, OJJDP is leading efforts to transform the juvenile justice system into one that will <u>Treat Children as</u> <u>Children</u>; <u>Serve Children at Home, With Their Families, in their Communities</u>; and <u>Open</u> <u>Up Opportunities for System-Involved Youth</u>. OJJDP encourages all proposed applications that work with youth to highlight how the proposed program aligns with these priorities.

OJJDP envisions a juvenile justice system centered on the strengths, needs, and voices of youth and families. Young people and family members with lived experience are vital resources for understanding and reaching persons involved or at risk of involvement with youth-serving systems. OJJDP asks stakeholders to join us in sustainably integrating bold, transformative youth and family partnership strategies into our daily work. OJJDP believes in achieving positive outcomes for youth, families, and communities through meaningful engagement and active partnerships, ensuring they play a central role in collaboratively developing solutions.

Applicants must describe how their proposed project/program will integrate and sustain meaningful youth and family partnerships into their project plan and budget. Depending on the nature of an applicant's proposed project, youth and family partnership could consist of one or more of the following:

- Individual-level partnership in case planning and direct service delivery (before, during, and after contact with youth-serving systems).
- Agency-level partnership (e.g., in policy, practice, and program development, implementation, and evaluation; staffing; advisory bodies; budget development).
- System-level partnership (e.g., in strategic planning activities, system improvement initiatives, advocacy strategies, reform efforts).

With this solicitation, OJJDP seeks to support the efforts of states, communities, jurisdictions, nonprofit organizations, for-profit organizations, and institutions of higher education to implement programs and strategies that identify, respond to, treat, and support children, youth, and families impacted by the opioid epidemic, and other substance use disorders, to ensure public safety.

#### **Statutory Authority**

Public Law 117-328, 136 Stat. 4459, 4538.

#### **Specific Information**

The opioid epidemic has become one of the most persistent epidemics in the United States, with nearly one million accidental drug overdose deaths, resulting in more than one fatal overdose death every five minutes.<sup>[1]</sup> Most of these overdoses are opioid-related and, since 2013, are primarily the result of illicitly manufactured fentanyl, a synthetic opioid 50 times more potent than heroin.<sup>[2]</sup> Recent trends show increased overdose rates among high school age youth.<sup>[3]</sup> While extensive work has been done to increase treatment capacity, there remains a significant burden on state and local law enforcement, substance use treatment delivery systems, mental health systems, child welfare and foster care, and the juvenile justice system.

Through this program, OJJDP will support states and communities to develop coordinated responses to opioid and other substance use-related challenges that impact youth and community safety. Funding may be used to support programs and services to youth and families impacted by both opioids and other substance use disorders.

#### **Goals, Objectives, and Deliverables**

This program will fund sites to develop coordinated intervention and prevention responses that identify and address challenges resulting from opioid and other substance misuse that impact youth, families, and communities. Proposed activities should incorporate harm reduction strategies as an overdose prevention technique that reduces the overdose risk, connects people who use drugs with access to treatment and recovery services, enhances health and public safety, and demonstrates a clear nexus between youth and the effects of opioids and other substances.

Sites will work with OJJDP and a training and technical assistance provider to develop a strategic plan that establishes baseline requirements and goals for their project.

#### Goals

The goal of the Opioid Affected Youth Initiative is to provide programs and services to youth and families impacted by both opioid use and other substance use disorders.

#### **Objectives**

Objectives include implementing prevention, intervention, and treatment programs that address the needs of pregnant and postpartum women, parents/primary caregivers, and youth; reducing foster care system involvement; implementing integrated services for parents and children that support families through treatment and recovery; and supporting the juvenile and criminal justice systems to address the needs of children and youth impacted by opioids and other substances.

#### Deliverables

Deliverables include the implementation of prevention, intervention, diversion, treatment, and recovery programs and strategies that respond to both opioid and substance use disorders and ensure sustainable outcomes for youth and families.

Sites will work in partnership with representatives from law enforcement, education, mental health service providers, child welfare agencies, community health agencies, and community-based organizations that address substance use.

Deliverables under this solicitation may include:

- Develop a youth and family advisory component, such as an advisory membership or committee appointment that elevates the leadership, expertise, and lived experiences of youth and families into actionable change.
- Create an overdose fatality review team to develop program and policy recommendations that will improve coordination and collaboration between public health, public safety, treatment and social service providers, and community coalitions to prevent future overdose deaths.

Any data or research referenced in the narrative should include information about the source of the data and/or a citation. Applicants should describe the target population and any previous or current attempts to address the problem. Applicants should describe any research or evaluation studies that relate to the problem and contribute to their understanding of its causes and potential solutions. While OJJDP expects applicants to review the research literature for relevant studies, they should also explore whether unpublished local sources of research or evaluation data are available.

#### b. Project Design and Implementation

Describe the strategy that will be used to address the problem/needs identified in the Description of the Issue and achieve the project's goals and objectives. List the proposed project activities and deliverables and describe how they relate to the stated objectives. Activities are the specific actions to be undertaken to fulfill the program's objectives and reach the program's goal(s). Provide a detailed description of the method(s) to be used to carry out each activity. Include details regarding any leveraged resources (cash or in-kind) anticipated from local sources to support the project, if any.
