## Synopsis

## **Program Description Overview**

The <u>U.S. Department of Justice</u> (DOJ), <u>Office of Justice Programs</u> (OJP), <u>Bureau of Justice</u> <u>Assistance</u> (BJA) is seeking applications for funding.

OJP is committed to advancing work that promotes civil rights and equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety, and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

With this solicitation, BJA seeks to provide financial and technical assistance to states, state courts, local courts, units of local government, and federally recognized Indian tribal governments to plan, implement, and enhance the operations of veterans treatment court (VTC) including service coordination, participant service and supervision coordination, fidelity to the VTC model, and recovery support services. VTCs effectively integrate evidence-based substance use disorder (SUD) treatment, mental health disorder (MHD) treatment, treatment for co-occurring disorders, mandatory drug testing, incentives and sanctions, and transitional services in judicially supervised criminal court settings that have jurisdiction over veterans with treatment needs in order to reduce recidivism, increase access to treatment and recovery support, and prevent overdose.

This program furthers the DOJ's mission to uphold the rule of law, to keep our country safe, and to protect civil rights.

## **Funding Category**

## Eligibility

For Category 1: Planning and Implementation and Category 2: Enhancement, eligible applicants are limited to:

- State governments
- Special district governments
- City or township governments
- County governments
- Public housing authorities/Indian housing authorities
- Native American tribal governments (federally recognized)
- Other:
  - Public or private entities acting on behalf of a single treatment court through agreement with state, city, township, county, or tribal governments

• Units of local government, such as towns, boroughs, parishes, villages, or other general purpose political subdivisions of a state

For Category 3: Statewide, eligible applicants are limited to:

- State agencies such as the State Administering Agency, the Administrative Office of the Courts, and the State Substance Abuse Agency
- State criminal justice agencies and other state agencies involved with the provision of substance use and/or mental health services, or related services for court and related criminal justice programming.

An applicant may submit more than one application, if each application proposes a different project in response to the solicitation. Also, an entity may be proposed as a subrecipient (subgrantee) in more than one application.

BJA will consider applications under which two or more entities (project partners) would carry out the federal award; however, only one entity may be the applicant for the solicitation. ## Program Description Overview

With this solicitation, BJA seeks to provide financial and technical assistance to states, state courts, local courts, units of local government, and federally recognized Indian tribal governments to plan, implement, and enhance the operations of VTCs including service coordination, participant service and supervision coordination, fidelity to the VTC model, and recovery support services. VTCs effectively integrate evidence-based substance use disorder (SUD) treatment, mental health disorder (MHD) treatment, treatment for co-occurring disorders, mandatory drug testing, incentives and sanctions, and transitional services in judicially supervised criminal court settings that have jurisdiction over veterans with treatment needs in order to reduce recidivism, increase access to treatment and recovery support, and prevent overdose.

This program furthers the DOJ's mission to uphold the rule of law, to keep our country safe, and to protect civil rights.

## **Statutory Authority**

Department of Justice Appropriations Act, 2024 (Pub. L. No. 118-42, 138 Stat. 25, 148).

## **Specific Information**

The focus of the VTC Program is to reduce the use of opioids, stimulants, and other substances, including alcohol, by veterans involved in the criminal justice system. Recognizing the significant increase and public health impact of overdose deaths, BJA also encourages a focus on treating SUDs and MHDs with access to evidence-based practices, including but not limited to medications for opioid use disorder (OUD), to prevent overdose and overdose deaths.

VTCs follow an evidenced-based model with core elements and performance standards that ensure the program is implemented in a manner that is likely to have the intended impact. Applications will be assessed on how well the applications comply with the model and standards, and other application requirements, as outlined in this section and the resource materials, which can be accessed via the links in the solicitation.

VTCs effectively integrate evidence-based SUD and MHD treatment, mandatory drug testing, incentives and sanctions, and transitional services in judicially supervised court settings that have jurisdiction over veterans in the criminal justice system who have SUD or MHD, including those with a history of violence and post-traumatic stress disorder (PTSD) and/or traumatic brain injury (TBI) as a result of their military service. In the proposal narrative, all applicants are required to describe a plan to serve all veterans with SUD who can benefit from this model.

#### Ten Key Components for VTCs

BJA provides applicants the flexibility to identify the most appropriate model on which to base their VTC in order to accommodate the needs and available resources of their jurisdictions, so long as the model conforms to the National Association of Drug Court Professionals (NADCP)

Ten Key Components of VTCs. These components are described in the BJA and Justice for Vets publication, <u>Ten Key Components of VTCs - All Rise.</u>

<u>Note</u>: Tribal Healing to Wellness courts (THWCs) may request funds to support a VTC docket and veteran-related services.

Access to Department of Veterans Affairs (VA) resources is a critical component of VTCs. The applicant must demonstrate the ability to expand services to veterans who are not accessing VTCs. The applicant must also demonstrate the ability to address barriers to VA resources, which include but are not limited to proximity to a VA facility and transportation. Of critical note will be the applicant's ability to build strategies to ensure access, safety planning, and assessment of risk for violence and self-harm in VTC programs and outreach/education to the veteran population and their families on VTC programming.

Most recent data from the publication, <u>Painting the Current Picture: A National Report on the</u> <u>Treatment Courts in the United States Highlights and Insights</u>, demonstrates a need to address equity and inclusion in treatment courts. In the proposal narrative, all applicants are *required* to describe a plan to collect and examine access and retention data to ensure disparities do not exist for race, color, religion, national origin, sexual orientation, gender, gender identity, or disability in admission protocols or elsewhere in the VTC program. This includes veterans who are not eligible for VA services.

The plan may include use of the <u>NADCP Equity and Inclusion Assessment Toolkit</u> or incorporate the <u>American University Racial and Ethnic Disparities (RED) Program Assessment</u> <u>Tool</u>. BJA will make training and technical assistance (TTA) available to grantees that plan to use either of these two assessment tools. BJA recognizes that sites may need assistance to evaluate their needs, identify the target population, ensure equity and inclusion in programming, track program implementation, and map critical resources in the community. To that end, BJA encourages exploration of partnerships with research experts to facilitate these evaluation and assessment activities.

<u>Note</u>: The applicant must demonstrate that eligible participants promptly enter the treatment court program following a determination of their eligibility. BJA will not award an applicant whose treatment court requires an initial period of incarceration unless the period of incarceration is mandated by statute for the offense in question. In such instances, the applicant must demonstrate that the person receives evidence-based withdrawal and treatment services, if available, while incarcerated and will begin treatment services immediately upon release. ## Medication to Treat SUD

The use of U.S. Food and Drug Administration (FDA) approved medications to treat SUD, in combination with counseling and behavioral therapies, is an effective, evidence-based treatment, including OUD. When VTC participants are diagnosed with an SUD, BJA **requires** grantees, where possible, to make all forms of FDA-approved medications to treat SUD available to the participants under the care and prescription of a physician. BJA will offer technical assistance to grantees to build or expand their capacity to provide access to all forms

for medications to treat SUD (sometimes referred to as medication-assisted treatment or MAT). For more information regarding BJA's provisions on MAT, visit: <u>https://bja.ojp.gov/sites/g/files/xyckuh186/files/media/document/adc-faq-medication-assisted-treatment.pdf</u>.

<u>Note</u>: Initially declared a public health emergency in October 2017, the opioid crisis remains a significant public health emergency. This crisis continues to take a devastating toll on the lives of individuals, families, and communities across the nation. In recent years, the increase in synthetic opioids in the nation's drug supply has only served to exacerbate and expand the reach of this devastation with over 106,699 drug overdose deaths in 2021, an increase of almost 14 percent from the prior year. Centers for Disease Control and Prevention data also show that overdose deaths disproportionately impact Black and American Indian/Alaska Native people.

To combat the morbidity and mortality of overdose and the chronic disease of OUD, it is critical that individuals with OUD have access to evidence-based, FDA-approved treatments. The Biden–Harris Administration has made addressing the overdose epidemic a priority, including increasing access to evidence-based treatment—namely, medications for OUD—across all settings.

In April 2022, the DOJ's Civil Rights Division published guidance further clarifying protections under the Americans with Disabilities Act (ADA) for individuals with OUD, including potential violations of the ADA by facilities or programs that do not allow individuals to be able to continue taking doctor-prescribed medication for opioid use disorder (MOUD). In fact, since then, courts, as well as <u>state and local correctional facilities</u> have faced <u>allegations</u> that the entities' refusal to permit the use of and provide MOUD violates the ADA. Similarly, a DOJ <u>findings report</u> regarding suicides and failure to provide MOUD in a county jail also helps to illustrate specific instances that were considered violations of the 8th and 14th Amendment rights of institutionalized persons. Both the guidance and enforcement matters reflect the federal government's position that a correctional facility's refusal to permit incarcerated individuals to continue or initiate treatment for OUD when clinically needed may violate the ADA, the Constitution, or both.

This information is intended to educate and inform you and your partners in considering your application to this solicitation; ways that this and other funding opportunities could help to further enhance your capacity to identify, screen, and assess individuals that may have SUD treatment and recovery support needs; and your work generally in support of the treatment and long-term recovery of individuals with SUD.

<u>Note</u>: Applicants are strongly encouraged to use BJA funds to provide overdose education, make take-home naloxone available to treatment court participants, and provide access to other harm-reduction strategies consistent with the veterans treatment model.

#### Controlled Substance Act

Award recipients are prohibited from using federal funds to support programs or activities that violate the Controlled Substances Act, 21 U.S.C. § 801, et seq, regardless of local or state practices or laws. Programs or activities funded under a BJA VTC award must ensure that

participants are tested periodically for the use of controlled substances, including medical marijuana. See: <u>34 U.S.C. § 10611, et seq.</u>

The FY24 VTC Discretionary Grant Program solicitation offers the following three grant categories:

**CATEGORY 1 PLANNING AND IMPLEMENTATION:** Planning and Implementation grants are available to eligible jurisdictions ready to commit to a 6-month planning phase followed by an implementation phase of an evidence-based VTC. The VTC must develop core capacity to provide critical treatment services, case management and coordination, judicial supervision, sanctions and incentive services, and other key resources such as transitional housing, relapse prevention, employment, and peer recovery support to reduce recidivism.

<u>Note</u>: The 6-month planning phase will incorporate VTC Foundational Training (FT). FT provides court teams with the skills necessary to build a program that integrates court and treatment functions and adheres to best practice standards. See: <u>VTC FT - All Rise</u> for details.

**CATEGORY 2 ENHANCEMENT:** Enhancement grants are available to eligible jurisdictions with an operational VTC. Funding may be used to assist a jurisdiction in scaling up its existing court program's capacity, provide access to or enhance treatment capacity or other critical support services, enhance court operations, expand or enhance court services, build or enhance collection and use of key drug operation and outcome data, or improve the quality and/or intensity of services based on needs assessments. Priority enhancements include transitional housing, transportation, and implementing a plan to expand services to veterans who cannot or do not have access to VA resources.

<u>Note</u>: It is recommended that an eligible entity (i.e., unit of local government or county including public and private entities) applying to Category 1 or Category 2 on behalf of an VTC attach a fiscal agent memorandum of understanding (MOU). See Additional Application Components in the Proposal Narrative discussion.

**CATEGORY 3 STATEWIDE:** Statewide grants are available to improve, enhance, or expand VTC services statewide. Statewide activities may include:

- Scaling up an VTC program(s) capacity.
- Helping local/rural/tribal jurisdictions to launch a new VTC as a grant subrecipient.
- Expanding treatment and services, including transitional housing and/or vocational training and support.
- Conducting an audit of the practice and the technical assistance for adherence to the Key Components of VTCs and best practices.
- Data collection and analysis to assess the practice and track recidivism and participant outcomes.
- Delivering TTA in coordination with national VTC resources.
- Supporting a VTC alumni network and/or peer recovery programs to serve VTC participants.
- Supporting the staff needed to expand services statewide.

<u>Note</u>: For applicants seeking to launch a new VTC and/or scale up an existing one, this program includes a subaward component, whereby the subrecipient is required to comply with all federal subaward requirements as described in <u>31 U.S.C. § 7502</u> and in <u>Title 2 C.F.R. § 200</u> (including,

but not limited to, the sections on "Subrecipient Monitoring and Management" contained in Subpart D and audit requirements applicable to subrecipients contained in Subpart F) and the OJP Financial Guide.

## **Solicitation Goals and Objectives**

#### Goals

To provide VTCs and professionals in the criminal justice system with the resources needed to plan, implement, enhance, and sustain evidence-based treatment court programs for veterans with SUDs who are involved in the criminal justice system in order to reduce recidivism, increase access to treatment and recovery support, and prevent overdose.

## **Objectives**

- Increase the number of potential participants screened (i.e., determine eligibility) and assessed (i.e., identity criminogenic risk, substance use or mental health conditions) from open to close of project period.
- Ensure all grantees administer mandatory and random drug and alcohol testing of program participants to help monitor substance use and treatment progress over the project period.
- Ensure all grantees provide or develop access to evidence-based SUD treatment, as well as recovery support services, over the project period.
- Ensure all grantees provide or develop the capacity to access all three forms of FDAapproved medications to treat SUDs over the project period.
- Increase graduation rates for all treatment court participants actively participating in the grant program from open to close of project period.
- Reduce the current recidivism rate among program participants actively participating in the grant program from open to close of project period.
- Ensure all grantees, over the project period, have access to BJA treatment court resources (e.g., TTA) needed to:
  - Effectively provide judicial and community supervision, mandatory and random drug testing, substance use and mental health disorder treatment, and appropriate incentives and sanctions.
  - Ensure the utilization of evidence-based practices and principles that incorporate the Best Practice Standards and other relevant research.
  - Ensure that all individuals eligible for the treatment court program have equivalent access as measured by the collection and examination of program data.

#### **Priority Areas**

In order to further OJP's mission, OJP will provide priority consideration when making award decisions to the following:

**1A.** Applications that propose project(s) that are designed to meaningfully advance equity and remove barriers to accessing services and opportunities for communities that have been historically underserved, marginalized, adversely affected by inequality, and disproportionately impacted by crime, violence, and victimization.

To receive this consideration, the applicant must describe how the proposed project(s) will address identified inequities **and** contribute to greater access to services and opportunities for communities that have been historically underserved, marginalized, adversely affected by inequality, and disproportionately impacted by crime, violence, and victimization. Project activities under this consideration may include, but are not limited to the following: improving victim services, justice responses, prevention initiatives, reentry services and other parts of an organization's or community's efforts to advance public safety. Applicants should propose activities that address the cultural (and linguistic, if appropriate) needs of communities, outline how the proposed activities will be informed by these communities, and implement culturally responsive and inclusive outreach and engagement.

**1B.** Applicants that demonstrate that their capabilities and competencies for implementing their proposed project(s) are enhanced because they (or at least one proposed subrecipient that will receive **at least 40 percent** of the requested award funding, as demonstrated in the Budget web-based form) are a *population specific organization* that serves communities that have been historically underserved, marginalized, adversely affected by inequality, and disproportionately impacted by crime, violence, and victimization.

For purposes of this solicitation, population specific organizations are nonprofit, nongovernmental, or Tribal organizations that primarily serve members of a specific underserved population and have demonstrated experience and expertise providing targeted services to members of that specific underserved population.

To receive this additional priority consideration, applicants must describe how being a population specific organization (or funding the population specific subrecipient organization(s)) will enhance their ability to implement the proposed project(s), and should also specify which historically underserved populations are intended or expected to be served or have their needs addressed under the proposed project(s).

**2.** BJA is committed to advancing work that supports the implementation and/or enhancement of VTC programs. In support of this OJP will provide priority consideration when making award decisions applicants that propose project(s) that are designed to implement and/or enhance VTC programs by demonstrating in their plan for the following strategies:

- Early identification of eligible veterans for referral to VTCs through strategies to coordinate with the VA and their local Veterans Justice Outreach Specialist (VJO) and to use Veterans ReEntry Search Service (VRSS) and/or the mobile SQUARES tools, which will help courts identify veterans. VRSS and SQUARES are free tools that the VA offers for justice system agencies to check the veteran status of defendants or incarcerated people. The use of VJOs and VRSS align with the <u>Ten Key Components of VTCs</u>.
- Developing and implementing a plan to expand services to veterans who cannot or do not have access to VA resources and/or groups of veterans who are not accessing VTCs in numbers representative of those veterans in the criminal justice system.
- Building strategies to ensure assessment of risk for violence and self-harm for veterans in veterans treatment programs, and appropriate supervision and service delivery.

<u>Note</u>: Addressing these priority areas is one of many factors that OJP considers in making funding decisions. Receiving priority consideration for one or more priority areas does not guarantee an award.

While the maximum allowable funding amount is \$2,500,000, OJP encourages applicants, including those that are new or that have never before received a federal award, to submit a proposed budget that best supports their project objectives and organizational capabilities, even if the proposed budget is at a lower amount than the maximum allowable funding level.

#### **Continuation Funding Intent**

OJP may, in certain cases, provide additional funding in future years to awards made under this funding opportunity through continuation awards. OJP will consider, among other factors, OJP's strategic priorities, a recipient's overall management of the award, and the progress of the work funded under the award, when making continuation award decisions.

This solicitation (notice of funding opportunity) incorporates guidance provided in the <u>OJP Grant</u> <u>Application Resource Guide</u> (Application Resource Guide), which provides additional information for applicants to prepare and submit applications to OJP for funding. If this solicitation requires something different from any guidance provided in the <u>Application</u> <u>Resource Guide</u>, the difference will be noted in this solicitation and the applicant is to follow the guidelines in this solicitation, rather than the guidance in the <u>Application</u> <u>Resource Guide</u> that is in conflict.

## How To Apply

#### Registration

Before submitting an application, all applicants must register with the System for Award Management (SAM.gov). An applicant must renew their registration every 12 months. If an applicant does not renew their SAM.gov registration, it will expire. An expired registration can delay or prevent application submission in Grants.gov and JustGrants. Applicants are encouraged to start the SAM.gov registration process at least 30 days prior to the application deadlines. Applicants who fail to begin the registration or renewal process at least 10 business days prior to the Grants.gov deadline may not complete the process in time and will not be considered for late submission.

#### Submission

Applications must be submitted to DOJ electronically through a two-step process that begins in Grants.gov and is completed in JustGrants.

This abstract should be in paragraph form without bullets or tables, written in the third person, and exclude personally identifiable information. It should also indicate if the applicant is requesting priority consideration, and if so, what type. Abstracts will be made publicly available on the OJP and USASpending.gov websites if the project is awarded. See the <u>Application Resource Guide</u> for an <u>example</u> of a proposal abstract.

They must also clearly describe the following for each court:

- State the total federal amount requested for the duration of the grant period (48 months). The Financial Management and System of Internal Controls Questionnaire helps OJP assess the financial management and internal control systems, and the associated potential risks of an applicant as part of the pre-award risk assessment process. Every OJP applicant (other than an individual applying in their personal capacity, not representing an applicant organization) is required to complete the web-based Questionnaire form in JustGrants. ## Brief Applicant Entity Questionnaire

The Office of Justice Programs (OJP) is collecting the following information to help assess its efforts to attract a broader range of applicants. #### **Proposal Narrative**

The Proposal Narrative should be submitted as an attachment in JustGrants. The attached document should be double-spaced, using a standard 12-point size font; have no less than 1-inch margins; and should not exceed 20 pages. If the Proposal Narrative fails to comply with these length restrictions, OJP may consider such noncompliance in peer review and in final award decisions. The applicant may include tables, charts, and graphs as part of the proposal narrative, but they must be in a legible font no smaller than 12-point. These items will count toward the page limit unless included as a separate attachment.

The Proposal Narrative must include the following sections:

#### a. Description of the Issue

Within this section, the applicant should explain their inability to fund the program adequately without federal assistance. For each category, the applicant must provide verified sources for the data that support the description of the issue (i.e., U.S. Census or other federal, state, and local databases).

# Category 1 Planning and Implementation Applicants, Category 2 Enhancement Applicants, and Category 3 Statewide Applicants

Explain their inability to fund the program adequately without federal assistance.

Indicate whether the applicant's jurisdiction is leveraging any other federal funding sources (e.g., Second Chance Act, Comprehensive Opioid, Stimulant and Other Substance Use Program, Coordinated Tribal Assistance Solicitation, Justice Reinvestment, or Justice Assistance Grant Program) to support the treatment court.

Indicate whether the applicant's jurisdiction has an active treatment court grant with BJA, the Office of Juvenile Justice and Delinquency Prevention, or the Substance Abuse and Mental Health Services Administration (include the grant number).

Describe the nature and scope of SUDs experienced by veterans in the jurisdiction, including related criminal justice involvement. Include data on race, ethnicity, age, gender, arrest volume (i.e., specifics of the general arrestee population, including the percentage screened for treatment court and what percentage of those are admitted into treatment court), and crime patterns for adult defendants.

Explain the problems with the current court's response to cases involving veterans with SUDs; identify how and to what extent the proposed program will address the current arrest volume; and describe how the current number of treatment slots meets the needs of anticipated referrals.

Describe current resources available and the gaps the applicant seeks to address with grant funding, particularly those that impact the collection of key program, recidivism, and treatment-related outcome data to assess the efficacy of the VTC.

Describe the proposed target population, including the criminogenic risk levels (high, medium, low), SUD treatment and recovery needs, and the average jail or prison sentence that potential participants face, if any.

Describe the tools that will be used to provide early and accurate identification of potential veterans for referral to the program (VRSS/SQUARES).

Indicate if veterans who are not eligible for VA benefits are eligible to participate in the program, and if so, describe what resources will be available to veterans who are not eligible to receive VA benefits.

Provide the target number of people for whom services will be provided under this program during the grant period (48 months). Explain how this target number was derived.

Describe how the applicant will prioritize court resources and services for veterans with high criminogenic risk and treatment needs, including those with repeat criminal justice involvement and SUDs.

Describe any current planning or coordination with related projects that shows the jurisdiction is preparing to plan and implement a VTC.

Describe the nature and scope of SUDs in the jurisdictions to be targeted. Include data on race, ethnicity, age, gender, arrest volume (i.e., specifics of the general arrestee population, including the percentage that would be screened for treatment court and what percentage of those that would be admitted into treatment court), and crime patterns for veterans.

Provide information about the extent to which the proposed program will use evidencebased treatment practices and/or services.

Describe how the applicant will address access to evidence-based treatment options, including all three forms of FDA-approved medication to treat SUDs and associated counseling and behavioral therapies, reducing risk for overdose and overdose fatalities, and supporting the provision of coordinated recovery support services such as transitional housing, peer support, and family related services. Indicate how those services are currently monitored or will be monitored for quality and effectiveness.

Confirm that access to all three forms of FDA-approved medications to SUDs will be provided.

Describe how the project proposes to enhance the potential for the long-term success of participants and graduates, including building positive supports for those in recovery in the programs.

In addition, **Category 2 Enhancement Applicants** should describe the current operation of the VTC, addressing the following:

- Referral, screening, and assessment process.
- Eligibility requirements.
- Target population.
- Current capacity.
- Length and phases of the program.
- Case management process.
- Community supervision.
- Recovery support services delivery plan, including vocational and/or educational, transitional housing, and peer recovery services.
- Family support services.
- Strategies to prevent and respond to risk for overdose.
- Judicial supervision.

- Incentives and sanctions.
- Graduation requirements and expulsion criteria (include which VTC team members are present when it is decided and communicated that a participant is terminated from the program).
- Restitution costs and all fees required for program participation.
- Indicate whether the VTC team to be funded has received training on the VTC model.
- Describe current efforts and planning that document that the jurisdiction is ready to enhance its VTC.
- Provide local data and any evaluation findings that demonstrate the program's impact with regard to participant recidivism and functional outcomes.
- Describe all program partners and what services they provide for program participants (VA, etc.).

In addition, Category 3 Statewide Applicants should provide the following:

- The state's current role and strategy to support existing and build new VTCs or other problem-solving approaches in courts.
- The extent to which the state and these courts meet the needs of the eligible population, whether they are operating at capacity, and the nonbudgetary reasons if they are not operating at capacity. Describe the issue or need.
- How applicant plans to enhance the capacity of treatment courts to use data and research; implement with fidelity to the VTC model, best practice standards, and 10 key components; and track program outcomes.
- Cite to data and any evaluation findings that demonstrate the state treatment court program's impact on the community and individuals involved in the criminal justice system.
- Other enhancements being proposed to support VTCs in the state.
- Areas where the state needs to enhance the capacity of treatment courts and practitioners statewide. Needs may be different based on the geographical location of the treatment court program (i.e., urban, suburban, or rural). If planning to implement or enhance TTA statewide, provide the target number of treatment courts for which TTA services will be provided. BJA will evaluate the grantee against this target number, so please include the data source used to determine the target number.

For **Category 3 Statewide Applicants** seeking to launch a new VTC and/or scale up an existing one, provide the following information for each court:

Proposed target population, including criminogenic risk levels (high, medium, low), SUD treatment needs, and the average jail or prison sentence that potential participants face, if any. Provide the target number of people for whom services will be provided under this program during the grant award period (48 months).

Problems with the local jurisdiction's current response to cases involving SUDs. Identify how and to what extent the proposed program will address the current arrest volume. Describe how the current number of treatment slots meets the needs of anticipated referrals.

Other challenges these jurisdictions face, including overdose and overdose fatalities, cooccurring mental health challenges, and other public health and homelessness challenges. Current efforts that document the jurisdiction is ready to plan and implement an adult treatment court. Indicate whether the treatment court team to be funded has received training on the treatment court model.

Documentation of the commitment of state and local jurisdictions to prioritizing court resources and services for individuals with high criminogenic risk and treatment needs, including persons with repeat criminal justice involvement and SUDs.

How applicant will map and develop more resources to support the program and how those services would be monitored for quality and effectiveness.

Local data and how applicant will assess and use any evaluation findings that demonstrate the program's impact with regard to participant recidivism and functional outcomes.

Gaps and/or locations that have more significant needs or limited capacity and services.

b. Project Design and Implementation

For this section, the applicant should address the following items and then address the specific category requirements below:

# Category 1 Planning and Implementation Applicants, Category 2 Enhancement Applicants, and Category 3 Statewide Applicants

State the name, location, and address where the proposed treatment court program is or will be operating.

Describe the applicant's plan to make sure that all individuals eligible for the treatment court program will have equivalent access to the program. This should include protocols for collecting and examining data on access to and retention in the program.

If the applicant is seeking priority consideration for Priority 1(A), it should address in this section how the proposed project(s) will promote racial equity and the removal of barriers to access and opportunity for communities that have been historically underserved, marginalized, and adversely affected by inequality, and identify how the project design and implementation will specifically incorporate the input or participation of these communities.

If the applicant is seeking priority consideration for Priority 2, it should:

- Describe a plan that demonstrates the early identification of eligible veterans for referral to VTC which may include coordination with the VA and a Veterans Justice Outreach Specialist (VJO) and the use of VRSS and SQUARES. VRSS is a free tool that the VA offers for justice system agencies to check the veteran status of defendants or incarcerated people. The use of VJOs and VRSS aligns with the <u>Ten</u> <u>Key Components of VTCs</u>.
- Developing and implementing a plan to expand services to veterans who cannot or do not have access to VA resources and/or groups of veterans who are not accessing VTCs in numbers representative of those veterans in the criminal justice system; or
- Building strategies to ensure assessment of risk for violence and self-harm for veterans in veterans treatment programs, and appropriate supervision and service delivery.

If the applicant is seeking priority consideration to expand access to services to rural and/or tribal communities, it should be addressed in this section how the proposed project(s) will identify rural and/or tribal communities and expand access to services consistent with the needs of the communities.

Describe the plan to provide treatment and services to address SUD and co-occurring SUD and MHD needs. Affirm whether the jurisdiction is able to provide program participants with access to all three forms of FDA-approved medications to treat SUDs as well as counseling and behavioral therapy services. This should include how participant treatment will be funded and the range of treatment modalities that will be provided.

Describe how the treatment provider(s) will be selected and address how the treatment court will monitor the provider(s). This monitoring should ensure the treatment is effective.

Describe the evidence base for the substance use and other treatment intervention(s) to be used and how responsive they are to the needs of the specific target population(s). If the evidence is limited or nonexistent for the target population, provide other information to support the intervention selection.

Demonstrate that the treatment court program(s) for which funds are being sought will not deny any eligible participant access to the program because of their use of FDA-approved medications for the treatment of an SUD as discussed under "Medication to Treat Substance Use Disorder" section.

Describe how the applicant will use funding to incorporate the evidence-based program principles included in <u>All Rise's 10 Best Practice Standards and the Ten Key Components of VTCs</u> and <u>Ten Key Components of VTCs</u>, and to specify which standard(s) will be addressed and how the standard(s) will be implemented and indicate the page numbers where each item is discussed in the proposal narrative.

Describe how the treatment court will identify, assess, and prioritize participation and services for high risk/high needs persons including persons with repeat criminal justice involvement and SUDs. Identify the validated assessment tool that will be used and why this tool is selected.

Discuss the applicant's commitment to admit and provide evidence-based interventions to participants with opioid, stimulant, and other SUDs, including strategies for early assessment and entry into treatment to prevent overdose. Describe the strategies that will be used during this phase to assess for the risk of overdose, the need for critical access to treatment services, and how to prevent overdose.

Demonstrate that eligible treatment court participants promptly enter the treatment court program following a determination of their eligibility. The applicant must also explain how participants will receive treatment services while incarcerated, if available, and will begin treatment services immediately upon release.

Describe how the applicant will ensure that while the VTC Program's authorizing statute requires participants to pay for treatment and restitution, it does not allow imposing a fee on a participant that would interfere with their rehabilitation. In the application, indicate how participants will be notified of the fee and include provisions for determining how these costs would not interfere with their rehabilitation or graduation.

Describe the community reintegration or continued care strategy detailing services to assist program graduates as they reintegrate into the community. The applicant should emphasize client access to transitional housing, including recovery housing. If applicable, the applicant is encouraged to consider and describe how their state's planned Medicaid expansion, waivers, and other state plan amendments will increase future program capacity or sustainability.

Describe the applicant's sustainability plan detailing how the VTC operations will be maintained after federal assistance ends. The sustainability plan should describe how current collaborations and evaluations will be used to leverage ongoing resources. BJA encourages the applicant to ensure sustainability by coordinating with local, state, and other federal resources such as the Edward Byrne Memorial Justice Assistance Grant (JAG) Program which has purpose areas to support court services and SUD treatment.

Attach an MOU signed by each key VTC team member with the responsibilities outlined for each as discussed under "Memorandum of Understanding Signed by Key VTC Team Members" in the Additional Application Components section.

Attach the job descriptions and résumés/CVs of key staff members.

Attach a letter of support from the local court outlining its commitment to the project.

If the applicant is seeking priority consideration under Priority 1(B), it should describe within this section how being a population specific organization (or funding a population specific subrecipient organization at a minimum of 40% of the project budget) will enhance its ability to implement the proposed project(s). It should also specify which historically underserved populations are intended or expected to be served or have their needs addressed under the proposed project(s), include the website address (if applicable), and formal or informal mission statement or principles of the population specific organization.

Category 3: Document that the grantee has enhanced and/or expanded the state's capacity to coordinate activities and expand services that support the needs of VTCs in the state, consistent with the requirements of this solicitation, including <u>All Rise's 10 Best Practice</u> <u>Standards and the Ten Key Components of VTCs</u>.

#### **Budget and Associated Documentation**

Budget narratives should demonstrate cost effectiveness in relation to potential alternatives and the objectives of the program. The total amount being requested must be identified on the SF-424 and program abstract. Applicants must submit the Budget Worksheet and Budget Narrative in the web-based form.

#### **Funding Restrictions**

The use of BJA grant funds for unmanned aircraft systems (UAS), including unmanned aircraft vehicles (UAV), and all accompanying accessories to support UAS or UAV, is unallowable. The

applicant should identify within their budget which items, services, etc., will/would be covered by matching sources and explain what type of match will be provided.

#### Letters of Support (Recommended)

Key team members include a judge, prosecutor, defense attorney, treatment provider, researcher/evaluator, management information specialist, community supervision representative, and treatment court coordinator. Applicants will submit the MOU by uploading the document as an attachment in JustGrants.

## Fiscal Agent Memorandum of Understanding Signed by Applicant and Treatment Court Administrator (recommended)

An entity (i.e., unit of local government or county) applying for funding on behalf of a VTC must attach a Fiscal Agent MOU that describes how it will coordinate directly with the treatment court for which funding is being sought and reflects agreement it will serve as the fiscal agent. The MOU must address the overall objectives of the VTC program as well as show support for

efforts to adhere to the evidence-based program principles included in 10 Key Components of VTCs and the Best Practice Standards.

<u>Note</u>: The treatment court administrator is a member of the VTC program and has authority to make decisions on behalf of the court. Applicants will submit the MOU by uploading it as an attachment in JustGrants.

#### Chief Justice, State Court Administrator, or Designee Letter (recommended)
